BPIR legislation - your questions

- Guidance to grouping products into BPIR documents e.g. can we group all of our shower cubicles across all of the sizes that all use the same factories for the trays, doors and liners.
- "The regulations only apply to building products that, when used in building work, may affect whether the building work complies with the Building Code."

However the guidance also states

"Products that are bespoke, one-off products are not intended to be captured by the regulations, ie products that are not based on a product line and are only produced for a specific project."

What does this mean for kitchen benchtops as they contribute to a building complying to G3?





BPIR legislation - your questions

• We sell toilets, tapware, parts, slide showers columns, handpieces, accessories, mirror, cabinets, baths, vanities, showers – all for commercial, retail and domestic purposes. Of the thousands of products how should we determine what products fit under BPIR and require a disclosure statement?





BPIR legislation - your questions

- I would like to know if there is any grace period for slow-moving stock?
- Do merchants need to host/store suppliers BPIR documents?
- How long do we have to provide access to a BPIR for a product we have previously sold but is now obsolete/no longer stocked?
- How often will the BPIR documents need to be updated?
- Are there other completed declarations to compare against?
- Is there somewhere to submit my draft declaration for checking to see that it complies?





Session 2 - Building Products and the Building Code

Allocation of building code clauses for products

- In most instances allocation is clear but there a few where genuine debate
- Developed a set of rules
 - Uses the relationship of product to "subject of code"
 - Following best practice such as Codemark certificates and BRANZ appraisals
 - Consistent interpretation of legal wording e.g. and/ors
 - Peer review by MBIE, BRANZ and BOINZ
