Heritage Carpets Econa Carpets are made with 100% Solution Dyed Nylon (ECONYL regenerated yarn) material. These carpets have a cut pile surface finish and loop pile construction comprising of solution dyed nylon face yarn, polypropylene primary backing, latex layer and secondary Polypropylene backing.

All Econa Carpets from Heritage Carpets have compliant, similar performance and fire characteristics.

Econa Carpets from Heritage Carpets are 366cm by default, also have 8 standard colours, They are available in multiple ranges that vary in weight.

Scope of use

Econa Carpets from Heritage Carpets **are suitable** for use indoors in residential environment:

Residential / Accommodation

They are suitable for use with underfloor heating and,

Can be installed over most clean, flat and dry surfaces.

They are not suitable for use:

On walls

In food preparation areas

In wet areas
